The Department has issued a new General State Operating Permit for Concrete Plants ("General Permit"). The permit was issued on June 28, 2013 and will be valid through June 30, 2023. Any violations found during these inspections may result in an enforcement action. Therefore, it is incumbent upon you to ensure you are in compliance with the General Permit at all times. It is important for you to read this issued permit carefully and to understand all requirements. If your facility no longer requires this permit, please submit DHEC Form D-2374 ("Permit Cancellation / Temporary Closure") to cancel your coverage under the General Permit. If coverage is not cancelled, you are responsible for all annual General Permit fees.

In the event, you disagree with the decision to approve the General Permit, or the terms and conditions of the General Permit, the enclosed "Guide to Board Review" explains the process for contesting the Department's decision.
