NO EXPOSURE CERTIFICATION for Exclusion from
NPDES Storm Water Permitting

A does not require permit authorization for its storm water discharges associated with industrial activity in South Carolina under the NPDES general permit for Storm Water Discharges Associated with Industrial Activity (except construction) (SCR000000) due to the existence of a condition of no exposure.

A condition of no exposure exists at an industrial site when all industrial materials and activities are protected by a storm resistant shelter to prevent exposure to rain, snow, snowmelt, and/or runoff. Industrial materials or activities include, but are not limited to, material handling equipment or activities, industrial machinery waste products. Material handling activities include the storage, loading and unloading, transportation, or conveyance of any raw materials and activities:

- drums, barrels, tanks, and similar containers that are tightly sealed, provided those containers are not deteriorated and do not leak. "Sealed" means banded or otherwise secured and without operational taps or valves;
- adequately maintained vehicles used in material handling; and

A NPDES permitting is available on a site-wide basis only, not for individual outfalls. If any industrial activities or materials are or will be exposed to precipitation, the site is not eligible for the no exposure exclusion.

A is certifying that a condition of no exposure exists at its facility or site, and is obligated to comply with the terms and conditions of S.C. R. 61-9. 122.26(g).

Who May File a No Exposure Certification

South Carolina law at S.C. R.61-9. Part 122.26 prohibits point source discharges of storm water associated with industrial activity to waters of the U.S. without a National Pollutant Discharge Elimination System (NPDES) permit. However, NPDES permit coverage is not required for

at S.C.R. 61-9 122.26(b)(14)(i)-(ix) and (xi) if the discharger can certify that a condition of "no exposure" exists at the industrial facility or site.

61-9 122.26(b)(14)(x) and (b)(15) are not eligible for the no exposure exclusion.

Obtaining and Maintaining the No Exposure Exclusion

This form is used to certify that a condition of no exposure exists at the industrial site described herein.

The industrial site operator must maintain a condition of no exposure at its site in order for the no exposure exclusion to remain applicable. If conditions change resulting in the exposure of materials and activities to storm water, the operator must obtain coverage under an NPDES storm water permit immediately.

Completing the Form

You must type or print, using uppercase letters, in appropriate areas only. One form must be completed for each site for which you are seeking to certify a condition of no exposure. Additional guidance on completing this form can be found in EPA's Guidance Manual for Conditional Exclusion From Stormwater Permitting Based on "No Exposure" of Industrial Activities to Stormwater (EPA 833-B-00-001). Please make sure you have addressed all applicable questions and have made a copy for your records before sending the completed form to the above address.

Section A. Operator Information

1. or any other entity that operates the facility or site described in this
The name of the operator may or may not be the same as the name of the facility. The operator is the legal entity that controls the site operation, rather than the plant or site manager.
2. Provide the telephone number of the operator.

3. Provide the mailing address of the operator (P.O. Box numbers may be used). Include the city, state, and zip code. All correspondence will be sent to this address.

Section B. Facility/Site Location Information

1. address (if no street address exists, provide a geographic description [e.g., Intersection of Routes 9 and 55]), city, county, state, and zip code. Do not use a P.O. Box number.
2. Enter the contact information of the person responsible for industrial stormwater compliance for the site.
3. Indicate whether the facility is located on Indian Lands.
4. Indicate whether the industrial facility is operated by a department or agency of the Federal Government (see also Section 313 of the Clean Water Act).
5. Enter the latitude and longitude of the approximate center of the facility or site in degrees/minutes/seconds. Latitude and longitude can be obtained from United States Geological Survey (USGS) quadrangle or topographic map. Otherwise, go to Topozone.com/viewmaps; put your nearest town and S.C. in the place search; select the town from the chart; then, under "Coordinate Format", Select D/M/S; move the map to your site with the arrows on the side of the map; place the pointer on your site. The latitude/longitude stated will be your lat/long.

Latitude and longitude for a facility in decimal form must be converted to degrees (°), minutes ('), and seconds (") for proper
To convert decimal latitude or longitude to degrees/minutes/seconds, follow the steps in the following example.

Example: Convert decimal latitude 45.1234567 to degrees (°), minutes ('), and seconds (").

- a) The numbers to the left of the decimal point are the degrees: 45°.
- b) To obtain minutes, multiply the decimal to the right of the decimal point by 60: 0.1234567 x 60 = 7.407402.
- c) The numbers to the left of the decimal point in the result obtained in (b) are the minutes: 7'.
- d) To obtain seconds, multiply the decimal from the result obtained in (b) by 60: 0.407402 x 60 = 24.44".
- e) The conversion for 45.1234567 = 45° 7' 44".

8. Enter the total size of the site associated with industrial activity in acres. Acreage may be determined by dividing square footage by 43,560, as demonstrated in the following example.

Example: Convert 54,450 ft² to acres
Divide 54,450 ft² by 43,560 square feet per acre:
54,450 ft² ÷ 43,560 ft²/acre = 1.25 acres.

9. Check "Yes" or "No" as appropriate to indicate whether you have paved or roofed over a formerly exposed, pervious area (i.e., lawn, meadow, dirt or gravel road/parking lot) in order to qualify for no exposure. Section C. Exposure Checklist

Section D. Certification Statement

South Carolina statutes provide for severe penalties for submitting false information on this application form. The form submitted must be printed, original document and signed by hand. South Carolina regulations require this application to be signed as follows:

, which means:

- (i) president, secretary, treasurer, or vice-president of the corporation in charge of a principal business function, or any other person who performs similar policy or decision making functions for the corporation, or
- (ii) the manager of one or more manufacturing, production, or operating facilities, provided the manager is authorized to make management decisions which govern the operation of the regulated site including having the explicit or implicit duty of making major capital investment recommendations, and initiating and directing other comprehensive measures to assure long term environmental compliance with environmental laws and regulations; the manager can ensure that the necessary systems are established or actions taken to gather complete and accurate information for permit application requirements; and where authority to sign documents has been assigned or delegated to the manager in accordance with corporate procedures;

For a partnership or sole proprietorship: by a general partner or the proprietor; or

For a municipal, State, Federal, or other public site: by either a
