



Preliminary Site Inspection Request For Proposed Agricultural Facilities

All areas are required to be completed, if not applicable, write N/A

This request form should be filled out completely and submitted to the local DHEC EA region office. Please see the back of this form for a complete listing of the region offices and the agricultural contacts. A representative will contact you as soon as possible to arrange an appointment. Two tax maps of the site and the surrounding 1320-foot radius of properties must be obtained prior to this meeting. The following items should be identified on these tax maps; adjacent land usage (residential, cropland, timberland, business, etc.), location of inhabited dwellings and wells, location of streams and ponds, location of ditches, and right-of-ways. This information should be labeled on the tax maps for all property within 1320 feet of the proposed facility's property line. The labeled tax maps must be submitted with this form prior to the meeting. The representative will review these maps and walk the proposed site to determine general suitability for a no-discharge agricultural facility and / or manure treatment/storage system.
