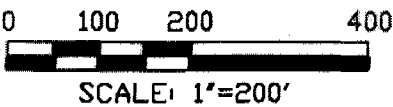
**DECK-CORNER CRITICAL LINE**

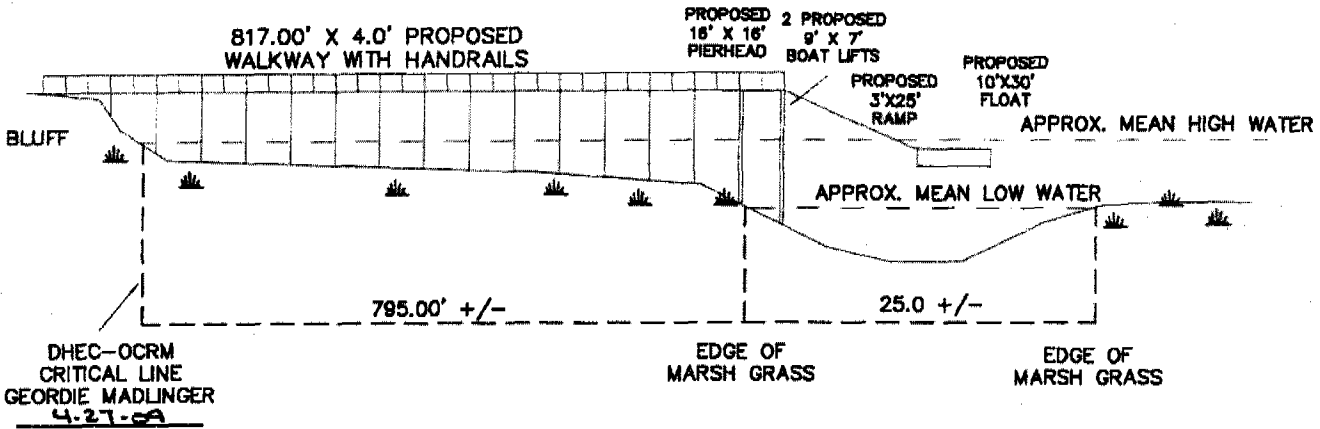
