AMENDMENT REQUEST**

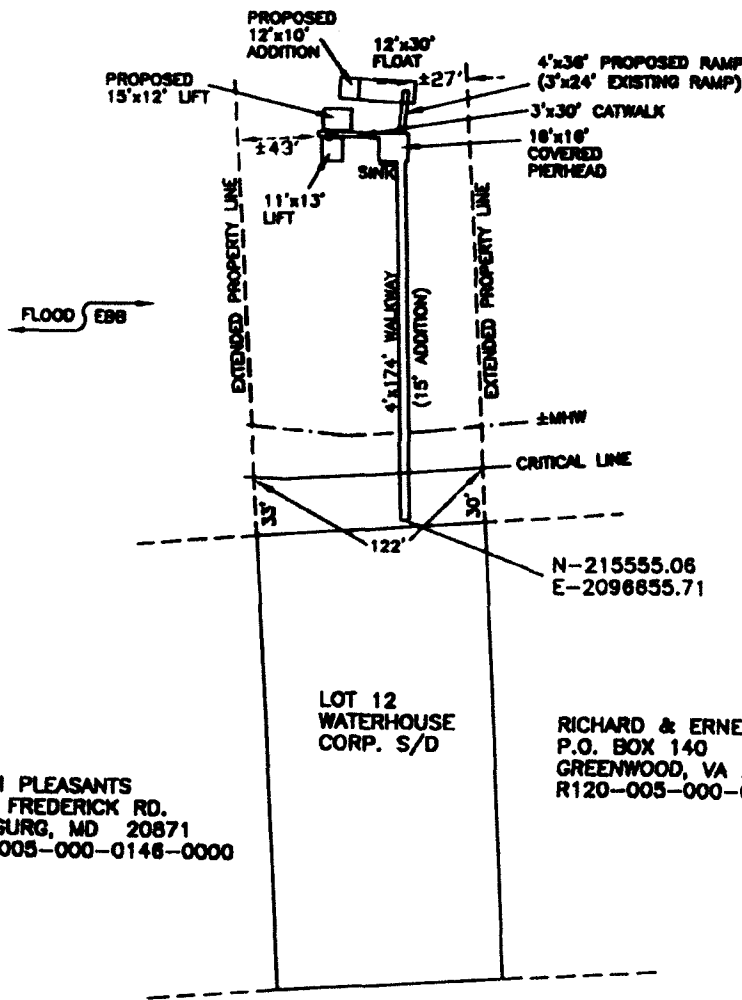

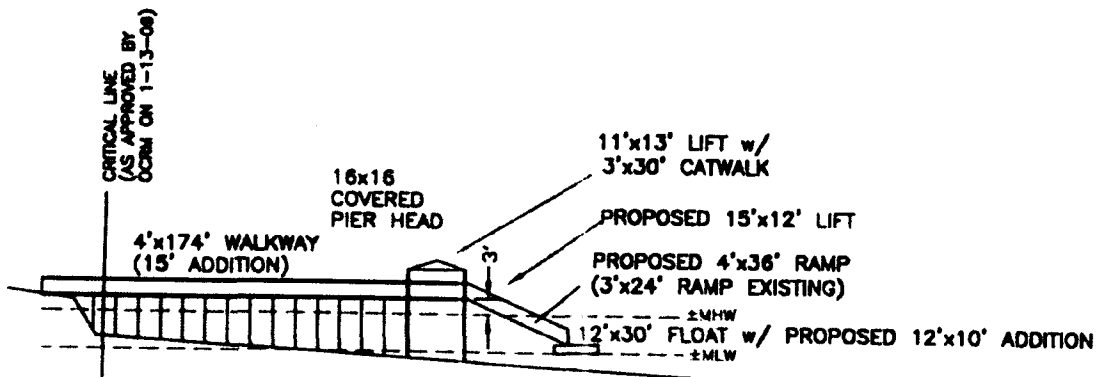
