





AMENDMENT REQUEST**

The permittee for P/N# **OCRM-08-026-T, Brittany Brandt**, has requested an amendment to that issued permit. Specifically, the applicant proposes to add a 3' x 3' x 100' riprap revetment along the face of an existing permitted bulkhead. The amendment request is for the addition of a riprap revetment to an existing bulkhead for additional erosion control on and adjacent to the marshes of Rat Hall Creek at 314 River Oak Drive, Grassy Creek, Mount Pleasant, Charleston County, South Carolina.

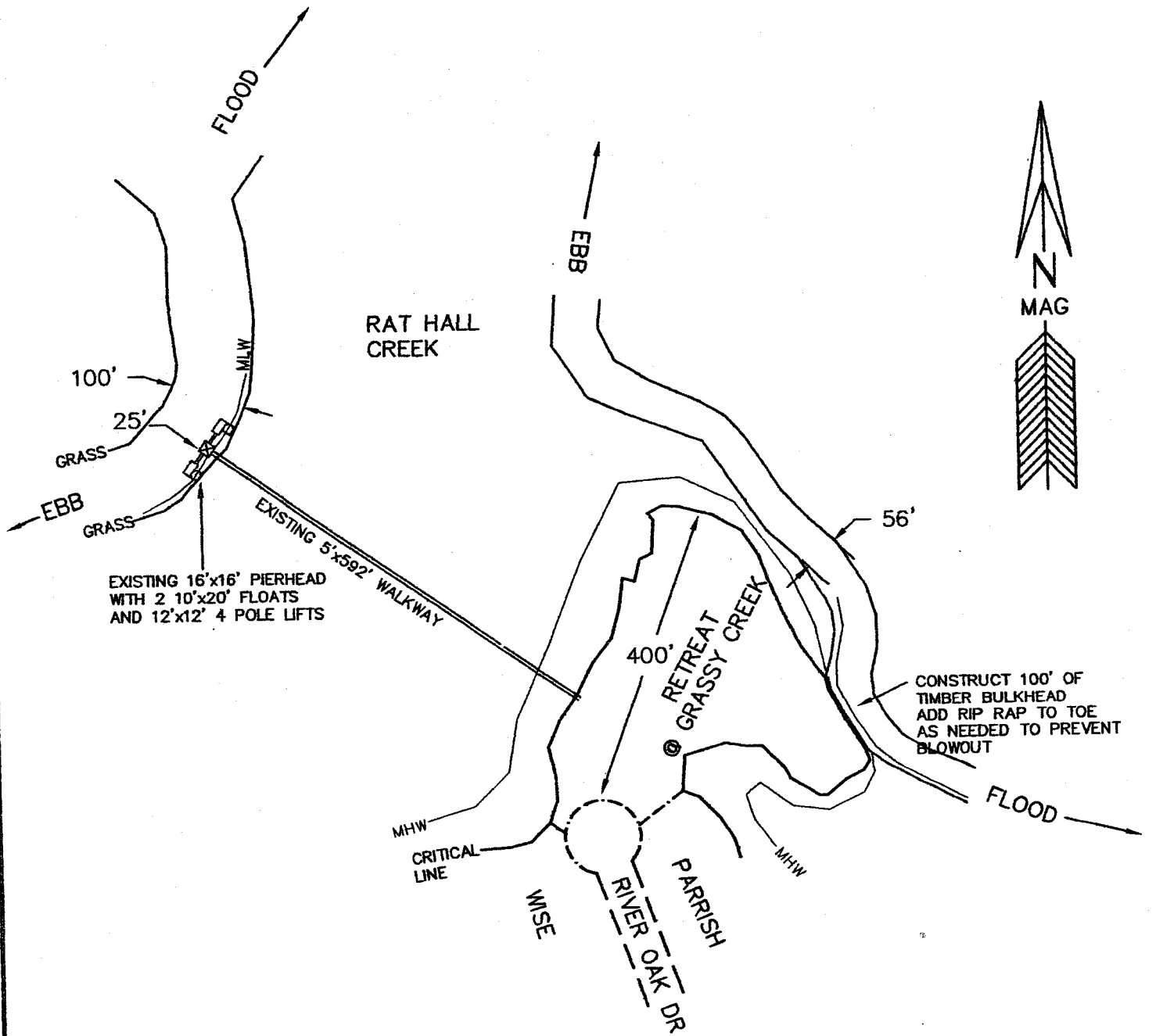

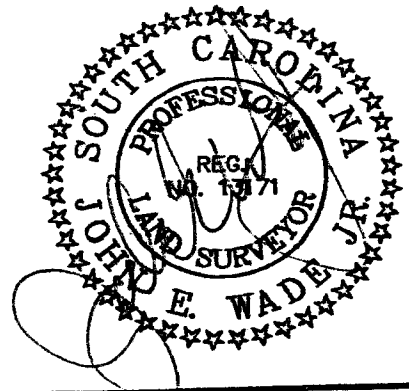

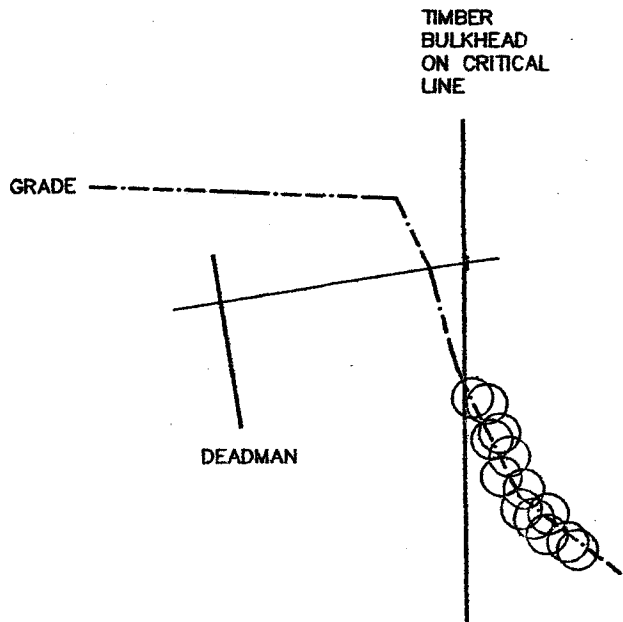

 (HEIGHT VARIES)

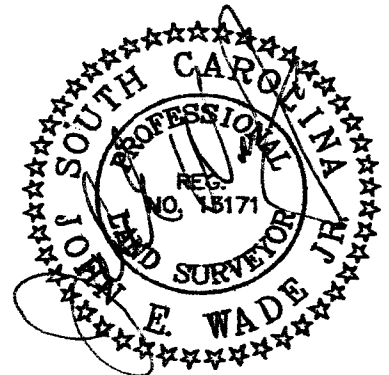
