## **PUBLIC NOTICE AMENDMENT REQUEST**

The permittee for P/N# **OCRM-09-855-G**, **Mark S Siegel**, has requested an amendment to that issued permit. Specifically, the applicant proposes to add a 3'x16'x38' catwalk to the ebb-side of the pierhead, relocate the permitted 12'x16' four pile boatlift to the ebb-side of the catwalk with a 15'x36' cover over the lift and add a 10'x12' four pile lift to the flood-side of the catwalk. The proposed amendment is for modifications to a private dock located on and adjacent to Battery Creek at 32 Wright's Point Circle, Port Royal, Beaufort County, South Carolina.

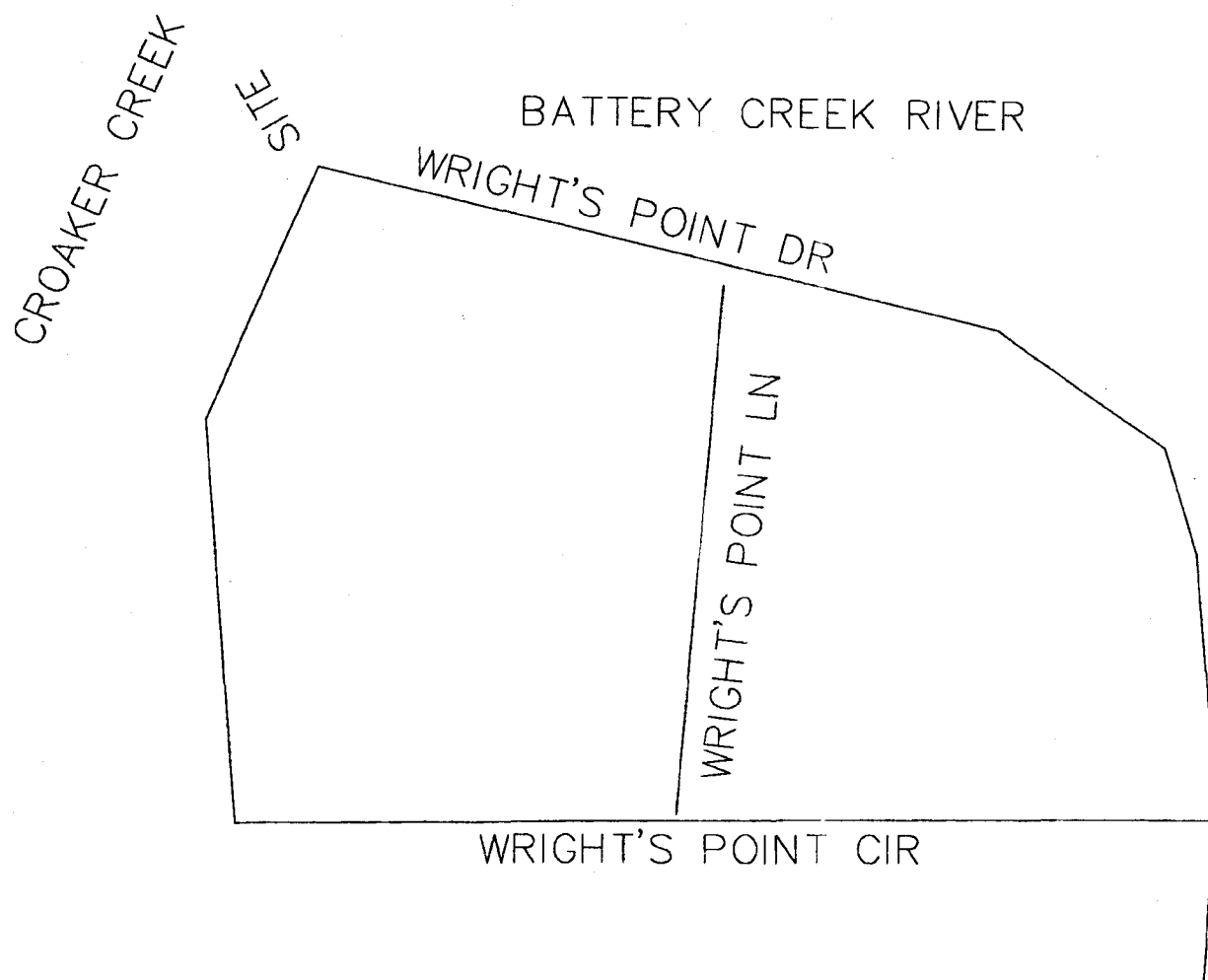
