PUBLIC NOTICE AMENDMENT REQUEST

The permittee for P/N# **OCRM-06-849, Stephane Malijenovsky**, has requested an amendment to that issued permit. Specifically, the applicant proposes to reconfigure the 12'x20' covered pierhead to a 16'x16' covered pierhead, enlarge the 10'x20' floating dock to a 12'x24' floating dock and move the beginning of walkway to the south to avoid specimen trees which will lengthen walkway by 10' for a total length of 695'. The proposed amendment is for modifications to private dock, on and adjacent to Brickyard Creek at 26 Piccadilly Circle, Pleasant Point Plantation, Lady's Island, Beaufort County, South Carolina.

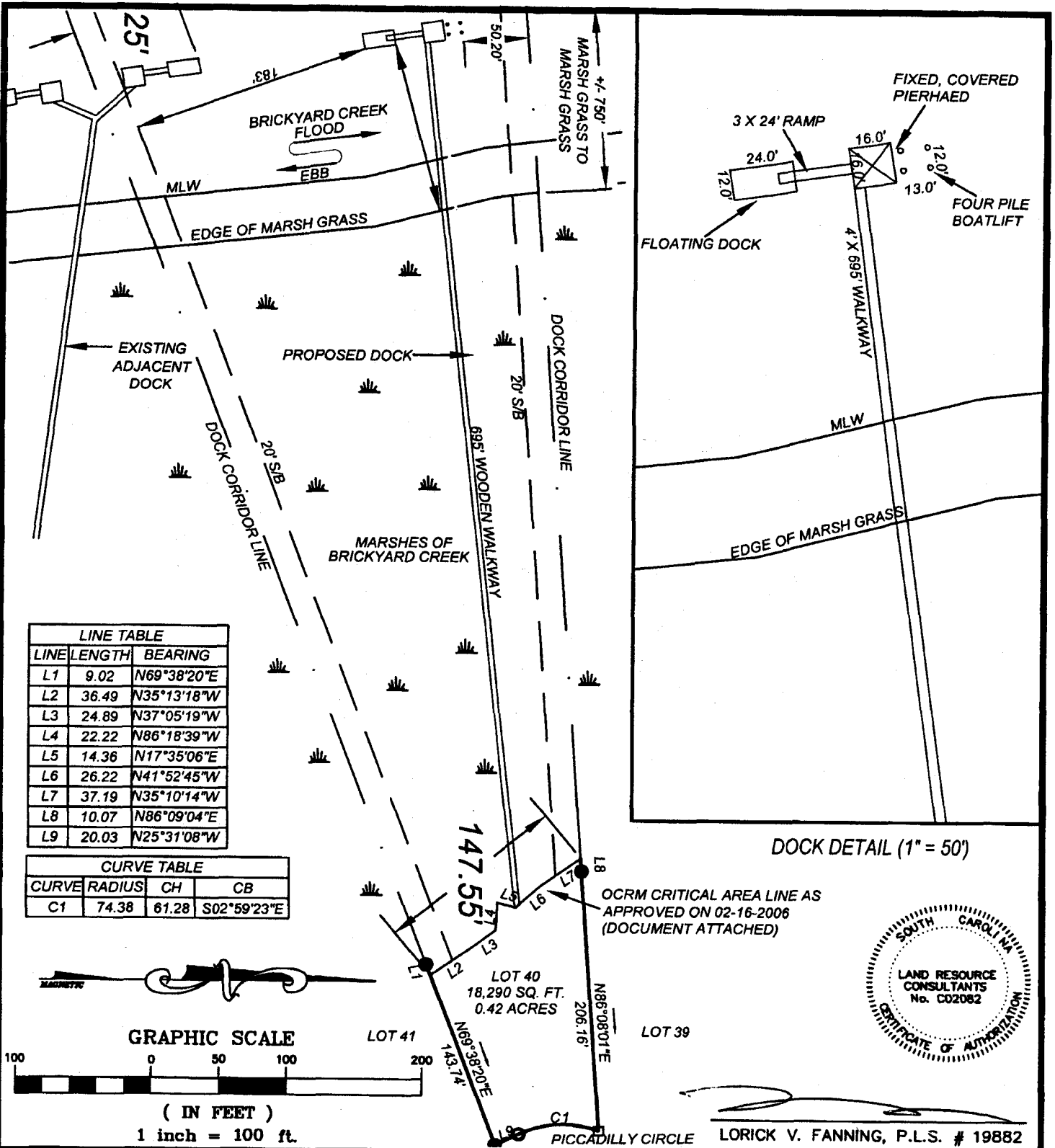

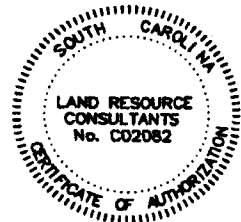

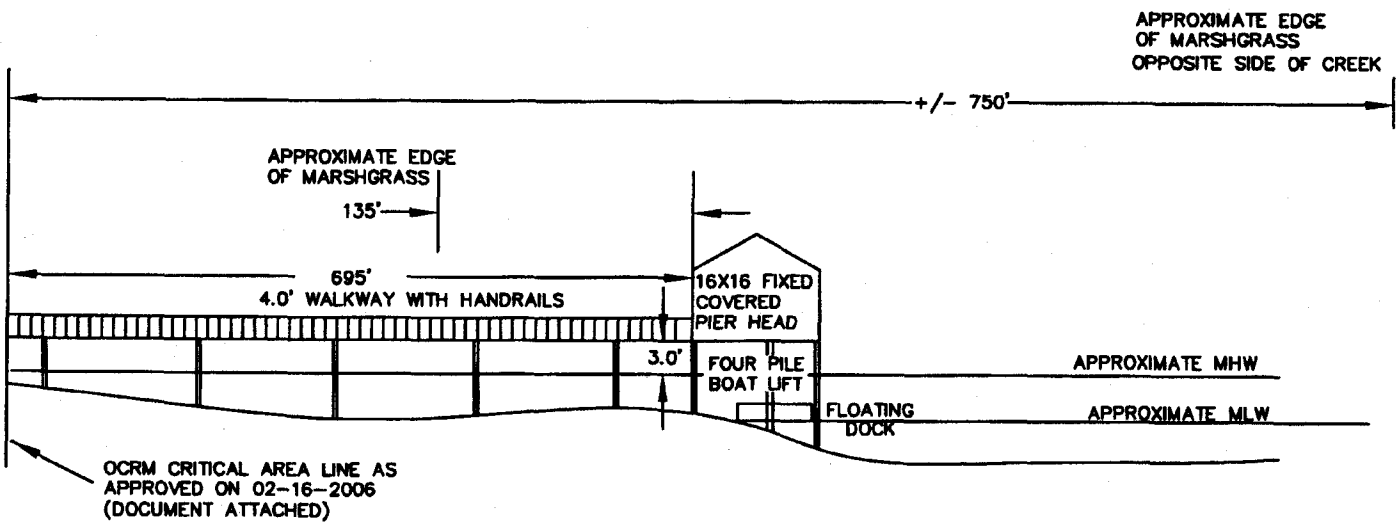
