VICINITY MAP



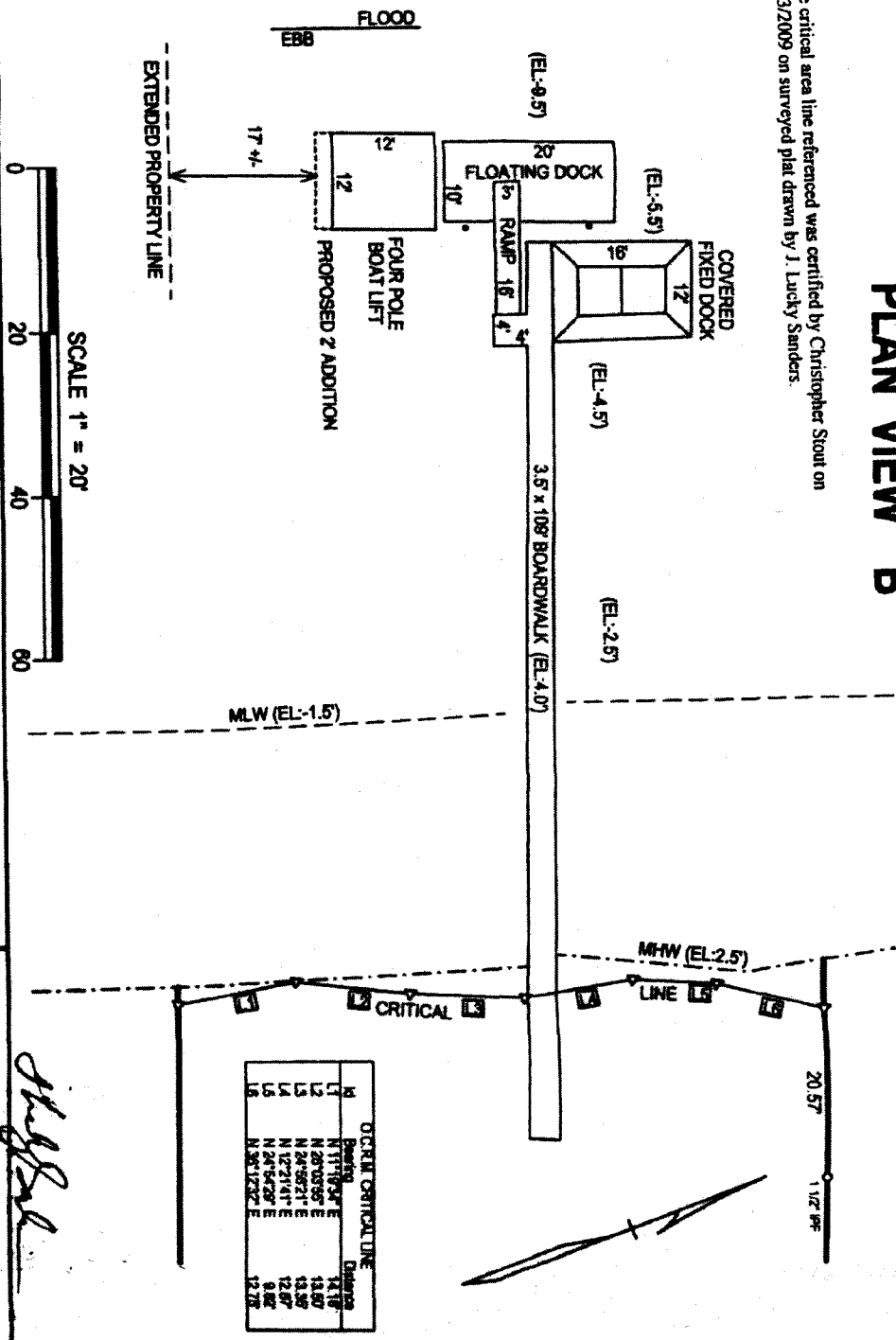

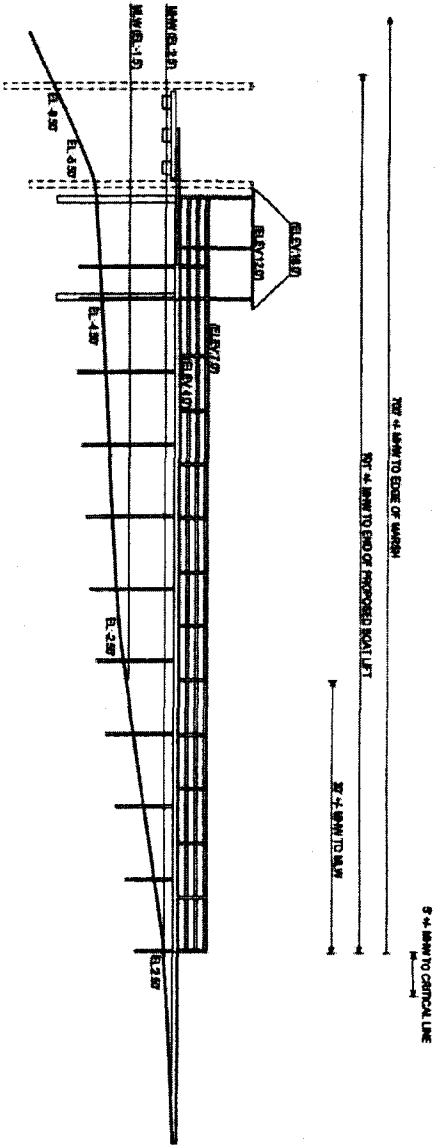

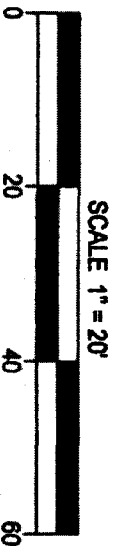
