  - I. **TITLE:** Administrative and Consent Orders issued by Environmental Quality Control ("EQC").
- II. **SUBJECT:** Administrative, Consent and Environmental Health Orders issued by EQC during the period January 1, 2011 January 31, 2011.
- III. FACTS: For the periods January 1, 2011 through January 31, 2011, EQC issued twentytwo (22) Consent Orders with total assessed civil penalties in the amount of \$60,319.00 and eight (8) Environmental Health Orders with total assessed penalties in the amount of \$3,000.00. One (1) Administrative Order was also issued during the reporting period with total assessed civil penalties in the amount of \$6,050.00.

Unless otherwise specified, "Previous Orders" as listed in this report include orders issued by Environmental Quality Control programs within the last five (5) years.

**ANALYSIS:** During the reporting period, the Underground Storage Tank Enforcement issued an Administrative Order against Jennifer Riley (Respondent) owner of Patterson Mill Grocery located in Barnwell, SC. Violations of the UST Regulations include failure to continuously provide corrosion protection for a temporarily closed UST; failure to test the corrosion protection system every three years and inspect it every 60 days; failure to properly abandon a temporarily closed system after twelve (12) months; failure to submit updated financial responsibility documentation; and, failure to pay the annual tank registration fees. The Respondent must submit documentation of the corrosion protection system being operational and copies of a recent test or close the tanks if the corrosion system has not been operational for the past twelve months. Documentation of financial responsibility needs to be submitted and the tank registration fees for 2011. A civil penalty in the amount of six thousand fifty dollars (\$6,050.00) was assessed.

Air Quality Enforcement entered into a Consent Order with Simpson Lumber Company, LLC (Respondent) located in Georgetown, SC. The Respondent failed to limit the particulate matter emissions from the gasification processes from a boiler during a Department approved source test. To comply with the Order, particulate matter emissions must be limited from the gasification processes of the boiler in accordance with the regulations. A civil penalty in the amount of nine thousand dollars (\$9,000.00) was assessed.

Onsite Wastewater Enforcement entered into three (3) Environmental Health Orders for sewage discharging onto the ground from a malfunctioning septic tank system. Total civil penalties were assessed in the amount of seven hundred fifty dollars (\$750.00).
