<u>Summary</u>: Fort Roofing & Sheet Metal (Individual/Entity), located in Sumter, South Carolina, owns and operates underground storage tanks (USTs). Department issued a Notice of Alleged Violation, for failure to display a registration certificate, in that the annual tank registration fees for fiscal year 2018 had not been paid. The Individual/Entity violated the SUPERB Act and the South Carolina Underground Storage Tank Regulation as follows: failed to pay annual tank registration fees for fiscal year 2018 in that annual tank registration fees were not paid on July 1, 2017; failed to provide records to the Department upon request in that requested records were not provided at the time requested; failed to determine the full extent of a release in that a site specific assessment plan/quality assurance project plan for an initial groundwater assessment were not provided upon request; failed to demonstrate financial responsibility and failed to provide a certificate of financial assurance upon request in that proof of a financial responsibility mechanism and a certificate of financial responsibility were not provided for fiscal year 2018.

<u>Action</u>: The Individual/Entity is required to submit a site-specific work plan/quality assurance project plan for an initial groundwater; submit a certificate of financial responsibility, proof of financial responsibility mechanism, and pay a civil penalty in the amount of three thousand, seven hundred fifty dollars **(\$3,750.00)**.
