IV. ANALYSIS:

Michael Black, 1194 Dalrymple Rd., Anderson, S.C. 29621. Under a Consent Order executed May 18, 2012, Mr. Black surrendered his South Carolina Emergency Medical Technician (EMT) – Paramedic Certificate. The Department then issued Mr. Black an EMT-Intermediate certification for a period of no less than six (6) months. Mr. Black agreed to attend an approved South Carolina Paramedic refresher course conducted by a South Carolina accredited institution, and to successfully complete the National Registry of EMTs (NREMT) written and practical exams. Successful completion of the NREMT exams must be provided to the Division of EMS and Trauma before the Department will reinstate Mr. Black's EMT-Paramedic certification. Mr. Black was found to have violated Regulation 61-7, Emergency Medical Servies, for failure to provide treatment and transport to a patient without mitigating circumstances, which resulted in a second response. Upon the second response, the patient's condition was notably deteriorated and the patient was later pronounced dead.

Previous Sanctions: None

Kristopher Lane, 1713 Haymount Road, Latta, SC 29565. Under an Emergency Suspension Order executed May 4, 2012, Mr. Lane's South Carolina Emergency Medical Technician Certificate was suspended immediately on an emergency basis. Mr. Lane was found to have violated Regulation 61-7, Emergency Medical Services, for unlawful distribution of a non-controlled, imitation controlled substance.

Previous Sanctions: None

Trevor Blum, 1430 Bavand Circle, Spt. 208, Rock Hill, SC 29732. Under an Emergency Suspension Order executed May 4, 2012, Mr. Blum's South Carolina Emergency Medical Technician Certificate was suspended immediately on an emergency basis. Mr. Blum was found to have violated Regulation 61-7, Emergency Medical Services, for theft of a controlled substance, 1<sup>st</sup> offense.
