
SC DHEC regulations require all Water Systems to initiate and maintain a viable Cross-Connection Control (CCC) Program. We are finding that many organizations do not have qualified/trained staff to properly create or administrate this mandatory program. This course is designed for Water System personnel who may be a part of administrating this program. Backflow basics will be explained to include Methods. Devices & Assemblies. State & Federal regulations will be presented. We will review the anatomy of a Cross-Connection Control Program. DHEC will discuss testing procedures for the PVB, DCVA, and RP assemblies.

### 6.0 hours of CEU credit will be awarded for this program.

In order to receive certification, DHEC will require that students attend the entire day of the workshop and pass a written exam.
