Dear CHRIS BAUER:

The South Carolina Department of Health and Environmental Control has made a minor modification to the NPDES General Permit issued to the above-referenced facility. The the site will now be able to mine a total of 62.3 acres, and 2 additional outfalls have been added (2BA & 3BA).

The effective date of the modification is October 5, 2020.

In addition to this NPDES general permit coverage, other permits may apply. Mines, other than borrow pits for SC DOT projects, are required to have a mine operating permit. Prior to implementing these changes to your NPDES general permit coverage, you may be required to request to modify your mine operating permit. Mine operating permits are issued through the Division of Mining and Solid Waste Management in the Bureau of Land and Waste Management.
