- I. TITLE: Administrative Orders, Consent Orders, and Sanction Letters issued by HEALTH REGULATION (HR).
- II. SUBJECT: Sanctions completed during the period January 1, 2007, through January 31, 2007.
- III. FACT: For the period January 1, 2007 through January 31, 2007, Health Regulation issued one sanction letter and three consent orders with total penalties of \$5,750.

- IV. ANALYSIS: 1. Trident Medical Center, 9330 Medical Plaza Drive, Charleston, SC 29406. Under a Consent Order dated December 21, 2006, the facility paid a penalty of \$1,900 and consented to make a recommendation that all medical practice privileges at Trident Medical Center be terminated for the licensed physician in question. The facility was found to have violated R.61-64, Title B, Rules and Regulations for Radiation Control by intentionally tampering with a dosimeter badge

Previous Sanctions: Under a Consent Order dated April 10, 2002, the facility paid a \$10,000 penalty for violation of R.61-64, Title B, Rules and Regulations for Radiation Control, resulting from the facility using two (2) cardiac catheterization laboratories that were not registered with the Department and the vendor supplying the units was not registered with the Department.

2. Courtlyn House, 10508 Garners Ferry Rd., Eastover, SC 29044. On March 13, 2006, the facility paid a \$600 monetary fee to satisfy a sanction letter. On October 30, 2006, the Department lifted the imposed suspension and ceased the licensed revocation. The facility was found to have violated R.61-84, Standards for Licensing Community Residential Care Facilities, for failure to meet the requirements for bringing the facility up to current building and fire and life safety codes.

Previous Sanctions: None.

3. Beverly Goode-Riley, 2327 Brian Christopher Road, Great Falls, SC 29055-8844. On January 12, 2006, the Department acknowledged receipt of \$1,750 for a Consent Order. The facility was found to have violated R.61-84, Standards for Licensing Community Residential Care Facilities, for failure to obtain a license.  
Previous Sanctions: None.

4. Blessed Births Family Wellness and Birth, 23 Mills Avenue, Greenville, SC 29605. Under a Consent Order dated January 25, 2007, the facility paid a penalty of \$1,500. The facility was found to have multiple violations and repeat violations of R.61-84, Standards for Licensing Birthing Centers for Deliveries by Midwives (Supp. 2005). Violations included: failure to complete personnel requirements, training documentation, completion of patient medical records, and required documentation of required fire drills.

Previous Sanctions: None.
