NOTICE OF PROPOSED MODIFICATION OF A
NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT

The South Carolina Department of Health and Environmental Control (DHEC) proposes to modify the National Pollutant Discharge Elimination System (NPDES) Permit #SC0025691, issued to ECW&SA/JOHNSTON #1 WWTP, (EDGEFIELD COUNTY/GREENWOOD EQC OFFICE) PO BOX 416, EDGEFIELD, SC 29824-0416. The facility is located off Sertoma Drive from Edisto Street, southeast of the Town of Johnston in Edgefield County. The facility has 1 discharge point: 001-treated sanitary wastewater, discharging to: South Fork Edisto River; The Standard Industrial Classification (SIC) Code for the facility is 4959. The receiving streams are classified Class FW: freshwaters suitable for primary and secondary contact recreation and as a source for drinking water supply after conventional treatment in accordance with the requirements of the Department. Suitable for fishing and the survival and propagation of a balanced indigenous aquatic community of fauna and flora. Suitable also for industrial and agricultural uses.

The proposed modifications are as follows:

1. Following Departmental approval of consultant-submitted Water Effects Ratio, Monitor & Report requirements have replaced numerical limits for Total Copper in Part III.A.1.
2. Part V.K has been added requiring the permittee to undertake additional measures for continued environmental protection if and when effluent concentrations exceed pre-determined values.

Persons wishing to comment on or object to the permit modifications are invited to submit same in writing within thirty (30) days of the date of this notice to the attention of: Murali C Koppa; SC DHEC; Water Facilities Permitting Division; 2600 Bull Street, Columbia, South Carolina 29201; Telephone: 803-898-4220. The permit number should be placed at the top of the first page of comments. When there is a significant degree of public interest in a permit or group of permits, the Department may hold a public hearing. SC DHEC is not involved in zoning, land use, or property value issues. Please contact your local County or Municipal officials for questions or concerns on these issues.

All comments received within the 30-day period will be considered in the formulation of final determinations regarding the permit. All persons submitting written comments will be notified of the final determinations. Requests for adjudicatory hearings may be filed after the above described determinations have been made. Additional information regarding adjudicatory hearings is available from the Legal Office at the above Department address or by calling 803-898-3350.
