Dear Mr. Moody:

The South Carolina Department of Health and Environmental Control (SCDHEC) has reviewed and approved the referenced workplan and associated monitoring well approval request. Please note the following:

- Well construction and sampling derived waste including but not limited to drill cuttings, drilling fluids, and development/purge water should be managed properly and in compliance with applicable requirements. If containerized, each vessel should be clearly labeled with regards to contents, source, and date of activity.
- Monitoring wells are to yield groundwater samples representative of the zone monitored per R.61-71 H.1.c of the South Carolina Well Standards and Regulations (e.g. low flow sampling techniques are recommended for samples to be analyzed for metals to reduce induced turbidity).
- > If metals are to be sampled, both total and dissolved metals should be analyzed. The dissolved metals are to be field filtered through a 0.45-micron filter.
- > The monitoring wells should be installed such that their screen brackets the water table aquifer.

- 4. All monitoring wells shall be labeled as required by R.61-71.H.2.c.
- 5. If any of the information provided to the Department changes, Chris Forrest ((803) 898-4252) should be notified a minimum of twenty-four hours prior to well construction as required by R.61-71.H.1.a.
